



AGREED UNDERTAKING by _____ to the **ABORIGINAL HEALTH WORKER BOARD OF THE NORTHERN TERRITORY**

A. ARRANGEMENTS FOR RE- REGISTRATION - TO WORK IN CLINICAL PRACTICE.

If you have not been in clinical practice as an Aboriginal Health Worker for more than 3 years and you intend to return to work in clinical practice the Board requires you to:

1. Complete the application for registration form and provide all documentation;
2. Complete the Senior First Aid Certificate, and
3. Complete an assessed by an accredited Workplace Assessor against the Clinical Care Competencies outlined in the NT customised Aboriginal Health Worker Competencies.

Once the Board has issued you with Conditional Registration you may start working while you do your Assessment and First Aid Certificate. Conditions on your registration will be on your Annual Practising Certificate. Conditional Registration will be continue up to the time you show a copy of your First Aid Certificate and an adequate Assessment of Competence report to the Board.

You are required to provide good reason to the Board if you have not completed the First Aid Certificate and the Assessment of Competence by the time you are required to renew your registration.

B. ARRANGEMENTS FOR RE-REGISTRATION IF YOU DO NOT INTEND TO WORK IN A CLINICAL PRACTICE

If you do not intend to work in Clinical Practice but you wish to or are required to be registered with the Aboriginal Health Worker Board.

Applicants must:

- Complete the application for registration form and provide all documentation;
- Provide a reference attesting to your competence IN THEIR AREA OF PRACTICE (eg Management/Administration Streams), and
- Complete the Undertaking below.

The Board will issue Registrations and the limitations to your registration will be available on your Annual Practising Certificate.

UNDERTAKING

- I will notify the Aboriginal Health Workers Registration Board on my intention to return to Clinical Practice after a period of 12 months/ 3 years (strike where applicable) in another AHW stream and agree to undergo the required demonstration of Clinical Care Competencies.
