PAYMENT DETAILS FOR ENVIRONMENTAL HEALTH REGISTRATIONS

The Environmental Health Program charges fees (GST exempt under Division 81 of the Commonwealth *GST Act*) for Boarding House and Barber Shop registrations. These fees must be payable to the Northern Territory Government's 'Receiver of Territory Monies' (RTM) by one of the following methods:

PHONE

Payment by credit card (MasterCard, Bankcard and Visa credit cards only) can be made over the phone to the RTM (see RTM phone numbers below). Once a credit card payment has been made then please fax through a copy of the application form to the nearest Environmental Health office – see DHF contacts below) and state on the application how the payment was made. **Please request that the RTM records the name of the premises on the receipt.**

ONLINE PAYMENT

Environmental Health fees cannot be paid online.

POST

If posting your completed application to Environmental Health then include a cheque or money order made out to the 'Receiver of Territory Monies'.

IN PERSON

Cash, cheque (made out to the 'Receiver of Territory Monies') or credit card at the following Department of Business and Employment RTMs then post or deliver the completed application and RTM receipt to Environmental Health.
